
The undersigned Steven J. Nielsen, being first duly sworn upon oath, deposes and says:



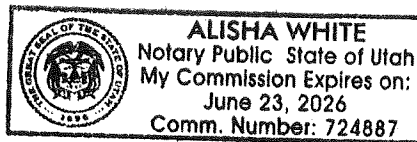
