AMENDMENT TO DECLARATION OF BONNEVILLE TOWER CONDOMINIUM

THIS AMENDMENT TO DECLARATION OF BONNEVILLE TOWER

CONDOWINIUM (this "Amendment") is entered into as of

the _____ day of May, 1990, by BONNEVILLE TOWER ASSOCIATION,

an Association of unit owners under the Utah Condominium Act,

(the "Association").

RECITALS

WHEREAS, Thompson Michie Associates, Inc., a Utah corporation, executed that certain Declaration of Bonneville Tower Condominium dated as of March 27, 1974 and recorded on March 28, 1974 as Fitry No. 2609076 in Book 3445 at Pages 145-178 in the Official Records of Salt Lake City, County of Salt Lake, Utah, (the "Declaration"), which pertains to certain real property located at 777 East South Temple, Salt Lake City, Utah, the legal description of which is contained on Exhibit "A" attached hereto and by reference incorporated herein; and

WHEREAS, the Association is comprised of the persons or entities who are at the time of this Amendment the unit owners of that certain condominium project commonly known as Bonneville Tower Condominium (the "Condominium"); and

WHEREAS, the Association desires to amend and modify the Declaration; and

whereas, the unit owners who own at least three-fourths (3/4) in the aggregate of ownership interest in the common areas and facilities of the Condominium have acknowledged their approval of the following amendments and modifications by executing and acknowledging certain instruments, which instruments are contained on Exhibit "B" attached hereto and by reference incorporated herein;

NOW THEREFORE, in consideration of the mutual covenants and obligations set forth herein, together with other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Association hereby agrees as follows:

- 1. Subparagraph 16.7 of the Declaration, with all subsequent amendments, if any, is hereby amended by deleting such subparagraph and amendments and substituting the following subparagraph in lieu thereof:
 - 16.7. The Management Committee shall establish and enforce the rental policy, which policy may change from time to time as provided within this Declaration and the Bylaws. Provided, however, that a simple majority of unit owners may override such rental policies established by the Management Committee. The simple majority

required by this Subparagraph 16.7 shall be established by one vote per unit.

- 2. Subparagraph 17.1 of the Declaration, with all subsequent amendments, if any, is hereby amended by deleting such subparagraph and amendments and substituting the following subparagraph in lieu thereof:
 - 17.1. No unit owner may transfer a unit or any interest therein by sale or lease without the approval of the Management Committee. No resident owner nor non-resident owner may own more than two (2) units.
- 3. The Declaration is hereby amended by deleting Subparagraphs 17.3, 17.3.1 and 17.3.2.
- 4. The Declaration is hereby amended by adding the following Subparagraph 17.10:
 - 17.10. Notwithstanding anything to the contrary, nothing in this Paragraph 17 shall permit the Management Committee to withhold approval against any person because of sex, race, creed, religion or national origin.
- 5. Subparagraph 21.1 of the Declaration is hereby amended by deleting such subparagraph and substituting the following subparagraph in lieu thereof:

- Except as otherwise provided in this Declaration and except as prohibited by the Utah Condominium Ownership Act, the provisions of this Declaration may be amended by a two-thirds (2/3) affirmative vote of the association of unit owners at a meeting duly called for such purpose. Upon such an affirmative vote, the Management Committee shall execute and acknowledge a writing setting forth the fact of the required affirmative vote of the unit owners, the satisfaction of such requirement, and the proposed amendment or amendments to the Declaration. The writing constituting the amendment or amendments to the Declaration shall be effective upon recording.
- The Declaration is hereby amended by deleting Section 9 and adding the following:

The agent to receive service of process in matters pertaining to the property is the Office Manager or any member of the Management Committee, at which service may be made at 777 East South Temple, Salt Lake Telephone: 801/355-7479. City, UT 84102.

7. Except as provided to the contrary herein, the Declaration shall remain unmodified and in full force and effect.
