NOTICE OF ADOPTION OF REDEVELOPMENT PLAN ENTITLED "3200 WEST - 3600 WEST 8600 SOUTH NEIGHBCRHOOD DEVELOPMENT PLAN" AND DATED JULY 16, 1990

Pursuant to Section 17A-2-1257, Utah Code Annotated, 1953, as amended, the following information is recorded in the Office of the Recorder of Salt Lake County:

(1) A Description of the Land Within the Project Area.

Beginning at a point which is North 33.00 feet from the East Quarter Corner of Section 5, Township 3 South, Range 1 West, Salt Lake Base and Meridian; and running thence West 182.00 feet; thence North 200.00 feet; thence East 149.00 feet to a point on the west right-of-way line of 3200 West Street; thence North 00°02'21" West along said right-of-way line 1094.15 feet; thence North 89°32'34" West 2618.46 feet; thence North 00°06'14" West 562.62 feet; thence North 69°53'42" East 2858.37 feet; thence South 00°02'21' East 2860.20 feet; thence West 33.00 feet to the point of Beginning. Contains approximately 68.25 acres.

(2) A Statement that the Redevelopment Plan for the Project Area has been Approved. The City Council of West Jordan City has adopted a redevelopment plan entitled "3200 West - 3600 West 8600 South Neighborhood Development Plan" dated July 16, 1990 by Ordinance No. 747 dated September 18, 1990.

(3) The Date of Approval. The Redevelopment Plan was approved on the 18th day of September, 1990 at the time the Ordinance was adopted and became effective on the 4th day of October, 1990 on the date that the Ordinance was first published.
