Judge: JENNIFER A BROWN

On August 20, 2019, a Request to Assign a Court Visitor was filed in this matter by a Heather Holbrook, which identified Ms. Holbrook as an interested person in this case.

While the Court appreciates Ms. Holbrook's involvement on behalf of Adult Protective Services, the request for a court-appointed visitor is denied, for the reasons set forth below.

- 1) There have been two previous court-appointed visitors involved in this case.
- 2) The first, Ed Jones, was stipulated to between the parties, and carried out his duties in a manner that was very helpful to the Court in making decisions early on in the case.
- 3) The second court visitor, William Fontenot, spent a significant amount of time meeting with each of the parties, and visiting with the protected persons, before submitting a lengthy written report to the Court.
- 4) That report was dated June 7, 2019, slightly more than two months before the request for a court visitor was received from Ms. Holbrook.
- 5) At this point, the involvement of yet a third visitor would be duplicative of the efforts that have already been undertaken, and likely would not assist the Court or the parties in addressing the issues that remain unresolved.
- 6) In addition, each party is currently represented by competent counsel who are attempting to work collaboratively, through mediation, to reach a resolution in this case.
- 7) Those attorneys have access to Mr. Fontenot's written report, and are able to approach the Court if they believe that another court visitor will be helpful to this process.

The Court acknowledges that it is quite possible that Ms. Holbrook was unaware of the involvement of the two prior court visitors in this case, and the Court certainly agrees that the use of a court visitor is very helpful to the Court in most instances. This ruling is intended to provide an explanation as to why the Court has declined that request under the circumstances of this case.

This is the final ruling of the Court on the matter of the appointment of an additional court visitor, and no further order is required.

This matter comes before the Court for a Hearing on Financial Accounting and Attorney Fees. The Court rules on the request for fees as to Landon Sandberg and grants the request.
