

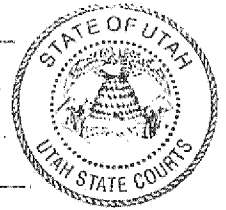

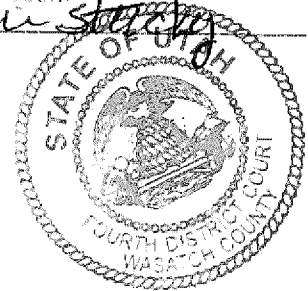

ORDER AND JUDGMENT

Plaintiffs' Motion for Summary Judgment ("Motion"), filed on or about April 2, 2021,
came before the Court for decision. The Court, have reviewed and considered the unopposed
Motion and the other written submissions of Plaintiffs, hereby CONCLUDES, FINDS and
ORDERS as follows:

Plaintiffs' Motion for Summary Judgment should be and is hereby GRANTED. The

Court concludes and finds that Plaintiffs are entitled to judgment as a matter of law on the claims pled against Defendants in Plaintiffs' Complaint.

WHEREFORE, by virtue of the law, and by the reasons of the premises aforesaid, it is hereby ORDERED, ADJUDGED, AND DECREED as follows:

1. Plaintiff Barbara Campbell-Cooper, as Trustee of The Barbara Campbell-Cooper Trust, is awarded judgment against Defendants Bonnie Berge-Drake and Ken Drake, jointly and severally, in the amount of **\$44,695.18**, representing the following damages:
 - a. Damages in the principal amount of \$37,023.12;
 - b. Court Costs¹ in the amount of \$501.25
 - c. Pre-judgment interest² pursuant to Utah Code § 15-1-1(2) at the pre-judgment statutory rate of 10% per annum in the amount of \$7,170.81 from August 6, 2018 through April 26, 2021.
 - d. Post-judgment interest to accrue on the judgment amount of \$44,695.18 at the post-judgment rate of 2.09% per annum, from April 27, 2021 until this judgment is paid in full.
2. Plaintiff Barbara Campbell-Cooper is awarded judgment against Defendants Bonnie Berge-Drake and Ken Drake, jointly and severally, in the amount of **\$1,167.43**,

representing the following damages:

- a. Damages in the principal amount of \$1,032.00;
- b. Pre-judgment interest³ pursuant to Utah Code § 15-1-1(2) at the pre-judgment statutory rate of 10% per annum in the amount of \$135.43 from January 3, 2020 through April 26, 2021.
- c. Post-judgment interest to accrue on the judgment amount of \$1,167.43 at the post-judgment rate of 2.09% per annum, from April 27, 2021 until this judgment is paid in full.

IT IS FURTHER ORDERED that the foregoing judgments may be augmented by the amount of reasonable costs and attorneys' fees incurred in collecting said judgments, by execution or otherwise, as shall be established by affidavit/declaration.
