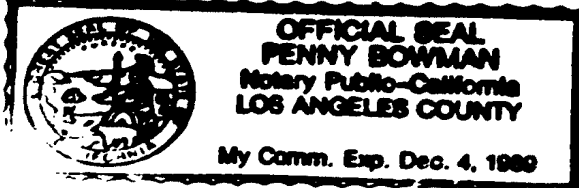

LEGAL DESCRIPTION

DESCRIPTION:

Situated in the county of Cache, state of Utah and described as follows:

A parcel of land in Lot 5, Block 33, Plat "A" Logan City Survey, situate in the Northwest Quarter of Section 34, Township 12 North, Range 1 East of the Salt Lake Base and Meridian, being further described as follows:

Beginning at the Northwest corner of said Lot 5; thence South 88° 49' East along the North line of said Lot 5, 102.00 feet, to an extension of an established fence; thence South 1° 11' West, along said fence extension, 60.00 feet; thence North 88° 49' West along an established fence 32.50 feet more or less to a point of record 60.00 feet South and 72.00 feet East of the Northwest corner of said Lot 5; thence North 1° 11' East along an established fence, 10.00 feet; thence North 88° 49' West 69.50 feet, to the West line of said Lot 5; thence North 1° 11' East along said West line 50.00 feet to the Point of Beginning.
