## WHEREAS

On January 31, 1990, by Order Number 90-248, the Director of the Office of Thrift Supervision (OTS) appointed the Resolution Trust Corportion (RTC) as receiver for MeraBank, a Federal Savings Bank (Old MeraBank). On that same date, the OTS, by Order Number 90-249, authorized and directed the incorporation of MeraBank Federal Savings Dank (New MeraBank), organized to take over the assets and liabilities of Old MeraBank, and by Order Number 90-250, the OTS appointed the RTC as conservator for New MeraBank. On October 1, 1990, the OTS, by Order Number 90-1818, appointed RTC as the receiver for New MeraBank:
