GRANT OF EASEMENT

KNOW ALL MEN BY THESE PRESENTS:

That the undersigned, Brian Head Resort, Ltd. ("Grantor"), for Ten Dollars (\$10) and other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, hereby grants, conveys, bargains and sells unto M.R. Crofts Associates, LLC, whose address is 363 South Valley View Drive, St. George, Utah 84770 ("Grantee"), its successors and assigns, a thirty five (35) foot wide, nonexclusive easement for ingress, egress and installation and maintenance of underground utilities across the real property located in Iron County, Utah described on Exhibit "A" attached hereto and incorporated herein by this reference.

This easement is granted for the ingress, egress and installation and maintenance of underground utilities for the benefit of one private, single-family residence owned by the Grantee and for no other purpose. The easement is appurtenant to Grantee's property, which is described on Exhibit "B" attached hereto and incorporated herein by this reference. Grantor makes no guarantees as to the condition of the road described in Exhibit "A" and Grantee accepts condition of the easement property "as is."

The Grantee agrees to defend, indemnify and hold harmless Grantor and its heirs, successors, assigns, employees and agents from any claim, loss, liability or expense of any nature incurred in connection with any activities of the Grantee, or any other person

or entity, during the term of this easement or related to the use of said easement. This indemnification shall cover all acts and omissions of any party relating in any way to this easement. The parties stipulate and agree that Grantor has no duty or obligation of any kind in relation to the easement and thus shall have no liability in relation thereto. This indemnification shall include all costs, attorney's fees and expenses incurred by Grantor in defending any and all claims.

The easement is subject to the following restrictions and agreements which are binding on Grantee and upon its successors and assigns as covenants running with the land:


- A. Grantee may install a private road from Burt's Road to his property at a distance of approximately four hundred eighty-six (486) feet, but in doing so shall create minimal disturbance to the property within the easement.
- B. Any installation or maintenance of utilities shall be done so as to create minimal disturbance to the property within the easement.
- C. Any disturbance (except for the actual roadway) shall be restored as nearly as reasonable to original condition immediately on completion of the improvements.
- D. This easement and Grantee's property shall be used only for one private single family residence by Grantee to be located as mutually agreed, and neither Grantee or its successors and assigns shall be allowed to extend this easement without a written agreement between both parties.
- E. The easement may be relocated by Grantor in it's discretion upon written notice to Grantee to a different location or route on Grantor's property, if necessary or convenient to the future development of Grantor's property.

These remedies shall be cumulative and may be exercised by Grantor in its sole and absolute discretion.
