REID, his wife, of Salt Lake City, Utah, GRANTORS, do hereby convey and warrant to the SALT LAKE CITY SUBURBAN SANITARY DISTRICT #1, Salt Lake County, State of Utah, GRANTEE, a Right-of-Way and Easement for the purpose of digging a trench along said Right-of-Way, and to lay, maintain, operate, repair, remove or replace a pipeline for transportation through and across the grantors' land and premises in Salt Lake County, State of Utah.

The Right-of-Way Easement herein granted is fifteen (15) feet wide the South line of which beings on a point on the North right-of-way line of Evergreen Avenue, said point being North 89°58' West along the section line 595.00 feet and North 0°03'15" West 25.00 feet from the South quarter corner of Section 26, Township 1 South, Range 1 East, Salt Lake Base and Meridian and running thence North 89°58' West along the North line of said Evergreen Avenue a distance of 140.00 feet.

TO HAVE AND TO HOLD the same unto the SALT LAKE CITY SUBURBAN SANITARY DISTRICT #1 so long as such pipeline shall be used and maintained, with the right of ingress and egress to and from said right-of-way, and to maintain, operate, repair and remove or replace the same. The said grantors shall not build hereon any permanent structure or building, nor plant large trees whose root zones would contact or interfere with the pipeline. The easement may, however, be crossed or covered with sidewalks, curb and gutter, roadways, driveways, fences or similar improvements.

THE GRANTEE HEREBY AGREES to replace or rectify any damages done to grantor's land or crops caused by grantee in the construction, maintenance, repair, operation or replacement of said line appurtenant facilities and to indemnify Grantors from any and all loss caused by the same.


