The following exception will apply specifically to items 7.2 and 11.1 of the Marquis Apartments ownership Declaration, and any other pertinent section of this document.

- 7. POWERS AND RESPONSIBILITIES OF THE MANAGEMENT COMMITTEE
- All maintenance, repair, replacement structural alteration, reconstruction and the operation of the Common Areas and Facilities, whether located inside or outside of the Homes, (unless necessitated by the negligence, misuse or neglect of an Owner in which case such expense shall be charged to such Owner). The interior surfaces of each Home shall be maintained and repaired by and at the sole cost of the particular Owner.
- PROHIBITION AGAINST STRUCTURAL CHANGES BY OWNER 11
- The Owner shall not, without first obtaining written consent of the Management Committee, make or permit to be made any structural alteration, improvement or addition in or to his Home or the Common Areas and Facilities. The Owner shall not paint or decorate any portion of the exterior of the building or other Common Areas and Facilities.
