THE STATE OF UTAH, by and through the UTAH DIVISION OF STATE LANDS, Grantor, in consideration of \$330.00, receipt of which from the Grantee is hereby acknowledged, and the promise of the Grantee to pay the Grantor \$10.00 on or before January 1, 1971 and \$10.00 every third year thereafter, hereby quitclaims to UTAH POWER & LIGHT COMPANY, Grantee, an easement for the construction and continued maintenance and repair of a pole line consisting of 266 single poles and 54 guy supports, to be located along a center line described as follows:

Beginning at the meander line of Great Salt Lake at a point 100 feet north and 2795 feet west, more or less, from the east one quarter corner of Section 12, Township 6 North, Range 4 West, SLM, thence South 12° 31' West 2661 feet, more or less, thence North 89° 51' West 6903 feet, thence South 88° 48' West 1080 feet, thence North 89° 59' West 11023 feet, thence North 69° 15' West 6016.8 feet, thence North 89° 39' West 3537.2 feet, thence North 71° 59' West 490 feet, thence North 89° 24' West 715.7 feet, thence South 54° 09' West 443.7 feet, thence North 88° 41' West 5028.6 feet, thence North 72° 58' West 488 feet, thence South 79° 01' West 583 feet, thence North 70° 59' West 527 feet, thence South 60° 57' West 4012 feet, thence South 18° 09' West 910 feet, more or less, to the meander line of Great Salt Lake and being within the meander lines of Great Salt Lake in Township 6 North, Range 4 West, SLM and Township 6 North, Range 5 West, Salt Lake Meridian.

Also, beginning in the above-described line at Utah Power & Light Company Survey Station 171 + 65, thence North 20° 38' West 701 feet on said land and being within the meander lines of Great Salt Lake in Township 7 North, Range 4 West, Salt Lake Meridian.

Also, beginning at the meander line of Great Salt Lake at a point 1650 feet south and 70 feet east, more or less, from the northwest corner of Section 25, Township 6 North, Range 6 West, Salt Lake Meridian, thence North 83° 51' West 680 feet, more or less, thence South 20° 47' West 1770 feet, thence South 51° 24' West 977 feet, thence North 88° 15' West 2003 feet on said land and being within the meander lines of Great Salt Lake in said Township 6 North, Range 6 West, Salt Lake Meridian.

Also, beginning at the meander line of Great Salt Lake at a point 2445 feet north and 65 feet west, more or less, from the southeast corner of Section 1, Township 6 North, Range 4 West, Salt Lake Meridian, thence North 0° 03' East 12653 feet, more or less, thence North 45° 47' West 922 feet, thence North 89° 43' West 5561 feet, thence North 89° 52' West 9321 feet on said land and being within the meander lines of Great Salt Lake in said Township 6 North, Range 4 West, Salt Lake Meridian and Township 7 North, Range 4 West, Salt Lake Meridian.

Also, beginning in the above-described line at a point 5665 feet north and .75 feet west, more or less, from the southeast corner of Section 1, Township 6 North, Range 4 West, Salt Lake Meridian, which point is Utah Power & Light Company Survey Station 50 + 92, thence North 89° 49' West 7206 feet, thence North 37° 25' West 248 feet, thence North 57° 39' West 1187 feet, thence North 84° 02' West 780 feet, thence South 55° 21' West 1553 feet, thence North 1° 59' West 720 feet on said land and being within the meander lines of Great Salt Lake in Township 7 North, Range 4 West, Salt Lake Meridian.

Also, beginning in the above-described line at Utah Power & Light Company Survey Station 72 + 06, thence South 1° 05' East 194 feet on said land and being within the meander lines of Great Salt Lake in Township 7 North, Range 4 West, Salt Lake Meridian.

Also, beginning in the above-described line at Utah Power & Light Company Survey Station 94 + 27, thence North 5° 52' East 273 feet, thence North 89° 53' West 2682 feet on said land and being within the meander lines of Great Salt Lake in Township 7 North, Range 4 West, Salt Lake Meridian.

Also, beginning at the meander line of Great Salt Lake at a point 255 feet north and 500 feet west, more or less, from the southeast corner of Section 1, Township 6 North, Range 4 West, Salt Lake Meridian, thence South 59° 06' West 1020 feet, more or less, to the meander line of Great Salt Lake and being within the meander lines of Great Salt Lake in Township 6 North, Range 4 West, Salt Lake Meridian.

TO HAVE AND TO HOLD until the Grantee, its successors or assigns fail to make any payment in accordance with its promise above set forth.

THE GRANTEE COVENANTS AND AGREES to relocate its poles and facilities hereunder, at its own expense, in the event relocation is necessary for the construction of highways by the State of Utah or any subdivision thereof, unless proportionate reimbursement of such costs has been obtained by the State of Utah or any such subdivision, pursuant to statutes of the State and the United States then in force, in which event the Grantee will be reimbursed for such costs in accordance with the applicable rules and regulations.

IN WITNESS WHEREOF, the said Grantor has caused these presents to be executed this 14th day of July, 1968, by the Director of the State Land Board, duly authorized by a resolution of said Board dated April 24, 1967.
