POWELL POWELLSON and JANNETTE POWELSON, his wife, Grantors, now residing in Canada but formerly of Utah County, Utah, hereby convey and warrant to UTAH POWER & LIGHT COMPANY, a corporation, its successors in interest and assigns, Grantee, for the sum of One (\$1.00) Dollar and other valuable consideration, a perpetual easement and right of way for the erection and continued maintenance, repair, alteration, and replacement of the electric transmission, distribution and telephone circuits of the Grantee, and 181 poles, with the necessary guys, stubs, cross-arms and other attachments thereon, or affixed thereto, for the support of said circuits, to be erected and maintained upon and across the premises of the Grantor, in Utah County, Utah, along a line described as follows:

Across the South part of the N. 1/2 of S. E. 1/4 Section 14, Township 10 S. R. 1 W., S. L. M.

Together with all rights of ingress and egress necessary or convenient for the full and complete use, occupation and enjoyment of the easement hereby granted, and all rights and privileges incident thereto, including the right to cut and remove timber, trees, brush, overhanging branches and other obstructions which may injure or interfere with the Grantes's use, occupation or enjoyment of this easement.

CERTIFICATE OF APPROPRIATION OF WATER

STATE OF UTAH

Application No. 154 UTAH LAKE JORDAN RIVER WATER DIVISION Certificate No. 731

Whereas, It has been made to appear to the satisfaction of the undersigned, State Engineer of the State of Utah, that the appropriation of water from the American Fork River in Utah County made by Utah Power & Light Co., Assignee, has been perfected in accordance with the application therefor, received in the office of the State Engineer, on the 7th day of July 1904 and recorded on page 617-619 in Book 1 of the Record of applications to appropriate water; WHEREFORE, Be it known that I, G. F. McGonagle, State Engineer of the State of Utah, under and by authority and direction of the provisions of Chapter 100 of the Laws of Utah, 1903, on "Water Rights and Irrigation," do hereby certify that the said Utah Power & Light Company, Assignee, of Salt Lake City, in Salt Lake County, State of Utah, is entitled to the use of 50.04 cubic feet of water per second subject to the following restrictions, to-wit:

The water is diverted from said river at a point which bears north 77° 34' 36" 19,732 feet from the northwest corner of Section 32, Township 4 South, Range 2 East Salt Lake Base and Meridian. The diverting works consist of a flume 6 ft. wide, 6 ft. deep, and 190 ft. long, a pipe line 11,710 ft. long and 36 inches in diameter, and 667 ft. of steel pressure pipe varying from 36 inches to 20 inches in diameter.

The water is used from January 1 to December 31, inclusive, of each year, to generate power for producing electric light and for propelling machinery in Utah County.

Two 60-inch wheels of the Pelton type, operating under a head of 520 ft., utilizing a maximum quantity of 50.04 cubic feet of water per second, are used for this purpose.

After having been so used, the water is returned to the natural channel of said stream at a point which bears north 85° 19' 45" east 8727.4 ft. from the northwest corner of said Section 32.

The diverting works must be maintained in such condition as will prevent an unreasonable loss of water.

The date of the appropriation is July 7, 1904.
