## RIGHT OF WAY DEED

John H. Price and Sarah E Price, his wife and H. Fred Price and Ruby Price, his wife grantors of Charleston, County of Wasatch State of Utah, hereby grants, bargains and sells to the STATE ROAD COMMISSION OF UTAH, Grantee, for the sum of Twenty-Eight and No/100 (\$28.00) DOLLARS, the following described right of way across the grantors' land in Wasatch County, State of Utah, as follows:

Right of Way for highway known as N. R. S. P. No. 151 across the grantor's land in the NW $\frac{1}{4}$  of Section 11, T. 4 S., R. 4 E., S. L. B. & M., being a strip 33 ft. wide (33ft. on the east side of the center line of survey of said project) so far as said strip is contained within the grantor's land. Said center line is more particularly described as follows:

Beginning at the south boundary line of said grantor's land, which produced, intersects said center line of survey at Engineer's Station 86 $\frac{1}{2}$ 59 which is approximately 64 ft. north, and approximately 22ft. west from the west  $\frac{1}{4}$  corner of said Section 11; thence North, 1122.0 ft. to the north boundary line of said grantor's land, which produced, intersects said center line of survey at Engineer's Station 97 $\frac{1}{2}$ 81 as shown on the official map of said project on file in the office of the Utah State Road Commission in Salt Lake City. Said tract of land contains approximately 0.85 acres, less approximately 0.57 acres now occupied by the existing highway. Balance 0.28 acres.

All irrigation ditches and canals shall be removed from within the limits of the above described right of way.

The purpose of this deed is to grant a perpetual right of way for highway purposes.

Wright and Jane Wright, his wife grantors of Provo, County of Utah State of Utah, hereby grants, bargains and sells to the STATE ROAD COMMISSION OF UTAH, Grantee, for the sum of Thirty-Seven and No/100 (\$37.00) DOLLARS, the following described right of way across the grantors' land in Wasatch County, State of Utah, as follows:

Right of way for highway known as N. R. S. P. No. 151 across the grantor's land in the NW $\frac{1}{4}$  of Section 11, T. 4 S., R. E., S. L. B. & M., being a strip 33 ft. wide (33ft. on the east side of the center line of survey of said project) so far as said strip is contained within the grantor's land. Said center line is more particularly described as follows:

Beginning at the south boundary line of said grantor's land, which produced, intersects said center line of survey at Engineer's Station 97 $\frac{1}{2}$ 81 which is approximately 1484 ft. south, and approximately 22 ft. west from the NW corner of said Section 11; thence North, 1484.0 ft. to the north boundary line of said Section 11, which produced, intersects said center line of survey at Engineer's Station 112 $\frac{1}{2}$ 65 as shown on the official map of said project on file in the office of the Utah State Road Commission in Salt Lake City. Said tract of land contains approximately 0.75 acres now occupied by the existing highway. Balance 0.37 acres.

All irrigation ditches and canals shall be removed from within the limits of the above described right of way.

The purpose of this deed is to grant a perpetual right of way for highway purposes.
