SUMMIT COUNTY, UTAH ORDINANCE NO. 332

AN ORDINANCE TO OFFICIALLY VACATE A PORTION OF, REALIGN AND RENAME PARK WEST DRIVE (A PUBLIC ROAD); AND TO VACATE PORTIONS OF PARK CITY WEST PLAT NO. 2 SUBDIVISIONS.

WHEREAS, a petition to vacate portions of a public roadway and subdivision plats in The Canyons Resort area was filed with Summit County on June 10, 1998, by ASC Utah, Inc., American Skiing Company Resort Properties, Inc., Wolf Mountain Resorts, L.C. and C&M Properties, L.L.C. - the owners of said property; and

WHEREAS, the Utah Code, Sections 17-27-808 thru 17-27-810 and Section 72-3-108 and the Snyderville Basin Development Code Section 3.9 provide mechanisms to vacate county roadways and subdivision plats; and

WHEREAS, a public hearing has been held with the Summit County Board of Commissioners on July 6, 1998, with notice provided as required in Utah Code, Sections 52-4-6, 17-27-809 and 72-3-108; and

WHEREAS, there is good cause to vacate and realign the portion of Major Drive and Park West Drive as described in the petition because the vacation and realignment will allow the construction of a new public roadway which will provide improved safety, accessibility and circulation to The Canyons Resort and adjacent properties in conjunction with new development in the area; and

WHEREAS, the vacation of the portion of Major Drive and Park West Drive as described in the petition will not be detrimental to the general interests of the community nor materially affect the access enjoyed by other property owners in the area; and

WHEREAS, the renaming of "Park West Drive" to "The Canyons Drive" will reflect the new identity of the area and, therefore, make it easier to locate individual addresses; and

WHEREAS. There is good cause to vacate the portions of Park City West Plat No. 1 and Park City West Plat No. 2 as described in the petition because the vacation will eliminate a number of platted single family lots in areas where this type of development is not appropriate and transfer the development rights to The Canyons Resort Base Village as directed in the Snyderville Basin General Plan; and

WHEREAS, the vacation of the portion of Park City West Plat No. 1 and Park City West Plat No. 2 as described in the petition will not materially injure any person or the public.

NOW, THEREFORE, the County Legislative Body of the County of Summit, State of Utah [hereinafter "Board"], ordains as follows:

Section 1. The Board hereby finds that neither the public nor any person will be materially injured by the subdivision plat vacations and there is good cause to approve the subdivision plat vacations because the vacation will allow a better development for the community which conforms to the Snyderville Basin General Plan.

Section 2. The Board hereby finds that the road vacation will not be detrimental to the general interests of the community nor will the access enjoyed by other property owners and the public be materially changed, and there is good cause to approve the vacation because the vacation will provide improved safety, accessibility and circulation to The Canyons Resort and adjacent properties.

Section 3. The Board hereby officially vacates the following as of the effective date of this ordinance:

- a. The portion of Park West Drive and Major Drive as described in Attachment A.
- b. The portion of Park City West Plat No. 1 as described in Attachment A.
- c. The portion of Park City West Plat No. 2 as described in Attachment A.

Section 4. The Board directs that the name "Park West Drive" be changed to "The Canyons Drive" for the entire length of roadway between Highway 224 and The Canyons Base area.

Section 5. This Ordinance shall take effect after 15 days of the date below and upon publication in a newspaper published and having general circulation in Summit County.
