DECLARATION AND NOTICE OF VESTED MINING USE

 - (c) Southside Gravel vested mining use is entitled to all of the rights, benefits and protections under Utah Code Ann. §§ 17-41-402.5, -501, -502 and -503.
- 3. <u>PURPOSE</u>. This declaration is prepared, pursuant to the Utah Code Ann. § 17-41-501(4)(a) for the purposes of recording notification as to the existence of a vested mining use with respect to the Property.
- 4. MINING PROTECTION AREA. The Property is located in a mining protection area pursuant to Utah Code Ann. § 17-41-101(11) and is entitled to all rights, benefits and protections under Utah Code Ann. §§ 17-41-306, -402 and -403.

Any such removal, addition or correction hereunder shall be effective upon recording of an amendment or supplement to this Declaration. Any amendment or supplement to this Declaration to incorporate additional real property interests under subsection 5(b) as part of Southside Gravel vested mining use declared hereunder shall relate back to the date this Declaration is dated.

- 6. <u>RUNS WITH THE LAND</u>. The vested mining use declared hereunder shall run with and bind the land within the Property as provided by Utah Code Ann. § 17-41-501(2), subject to abandonment by Southside Gravel, its successors and assigns, pursuant to Utah Code Ann. § 17-41-503.
