of Wellsville Cache Utah Grantee  
for the sum of One and no/100 (\$1.00), State of Cache Dollars,  
the following described tract of land in Cache County, State of Utah,  
to-wit:

A parcel of land situated in the NW 1/4 SE 1/4 of Section 10, T. 10 N., R. 1 W.,  
S. L. M., the approximate boundaries of which are described as follows:

Beginning at the intersection of the westerly boundary line of said  
grantors land and the westerly right of way line of highway known as P. A. Project  
No. 33, which point is approximately 2168 feet north along the east boundary  
line of said Section 10 and approximately 30 rods west from the SE corner of said  
Section 10; thence Northerly 260.0 feet, more or less, along said westerly boundary  
line to the center line of a U.S.R.R. Canal; thence N.30°44' E., 37.8 feet along  
said center line of canal; thence N.70°36' E., 182.8 feet, along said center line  
of canal to an intersection with said westerly right of way line; thence S.32°30' W.,  
387.9 feet, more or less, along said right of way line to point of beginning, as  
shown on the official map of said project on file in the office of the State Road  
Commission of Utah. Above described parcel of land contains 0.61 acre, more or less,  
of which 0.13 acre, more or less, is now occupied by the canal right of way. Balance  
0.48 acre, more or less.

In executing this deed, the grantor hereby reserves any and all rights of  
ingress to, or egress from the above described property over and across the above  
described northwesterly right of way line of said highway.

The grantor also reserves the right to locate and construct upon the above  
described premises, all irrigation ditches made necessary by the construction of  
said project.




