SECOND AMENDMENT TO

SHAUGHNESSY APARTMENTS CONDOMINIUM DECLARATION

Pursuant to provisions of Chapter 8 of Title 57 of the Utah Code Annotated, as amended, known as the Utah Condominium Ownership Act (hereinafter "the Act") and Paragraph 21.1 of the Shaughnessy Apartments Condominium Declaration (hereinafter "the Declaration"), this instrument is executed and approved on the dates hereinafter set forth by unit owners whose signatures appear hereafter and who own at least three-fourths (3/4) in the aggregate of ownership facilities and the common areas interest in Shaughnessy Apartments Condominium.

WHEREAS, on February 18, 1978 certain real property described in Appendix C to the Declaration of the Shaughnessy Apartment Condominium was committed to the provisions of the Act by recording said Declaration as Entry No. 2786509, Book 4108, Page 181 at the Office of the Salt Lake County Recorder, Utah;

WHEREAS, said Declaration was amended on January 30, 1979 by recording a First Amendment to said Declaration as Entry No. 3230729, Book 4807, Page 573 at the office of the Salt Lake County Recorder; and

WHEREAS, the individual owners who have signed below are desirous to amend several provisions in the Declaration in certain respects.

NOW, THEREFORE, and for that purpose, the Declaration is hereby amended as follows:

- Paragraph 1.1 is amended to read as follows:
 - 1.1 Declarant, and the persons joining in this declaration, are the sole owners of the real property and improvements ("property") located at 247-251 South 700 East, Salt Lake City, Salt Lake County, Utah hereinafter more particularly described.
- Paragraph 1.7 is amended to read as follows:
 - 1.7 The property shall be known as the Shaughnessy Apartments Condominium. The address of the property is 247-251 South 700 East, Salt Lake City, Utah 84102.
- Paragraph 8.2.6 is amended to read as follows:
 - 8.2.6 A unit owner shall not permit any sign of any kind to be displayed to the public view from their unit or from the limited common areas and facilities appurtenant to his unit, that is not consistent with the purpose stated in 8.1.
- 4. Paragraph 8.2.8 is amended to read as follows:

- 8.2.8 A unit owner shall not permit any illegal activity or nuisance to be carried on his unit or in the limited common areas and facilities appurtenant to his unit.
- 5. Paragraph 10.2 is amended to read as follows:
 - 10.2 The management and maintenance of the property and the business, property and affairs of the Shaughnessy Apartments Association ("association") shall be managed by a management committee, consisting of five (5) members who shall be unit owners. The management committee shall be elected as provided in the by-laws.
- 6. Paragraph 10.4 is amended to read as follows:
 - 10.4 The management committee may delegate to a manager or managing company all of its foregoing powers, duties and responsibilities referred to in paragraph 10.3 above except: the final determina-

tion of common expenses, budgets and assessments based thereon; the provulgation of house rules and administrative rules and regulations; the power to enter into any contract involving more than \$500.00 in any one fiscal year; the opening of bank accounts; the power to purchase, hold, sell, convey, mortgage or lease units in the name of the association or to bring, prosecute and settle litigation.

- 7. Paragraph 12.1 is amended to read as follows:
 - 12.1 The management committee shall obtain and maintain at all times insurance of the type and kind as provided herein and including insurance for such other risks, of a similar or dissimilar nature, as are or shall hereafter customarily be covered with respect to other properties similar to the property in construction, design and use. The management committee shall make every reasonable effort to obtain insurance with the following provisions or endorsements, if possible.
- 8. Paragraph 12.1.1 is amended to read as follows:

- 12.1.1 Exclusive authority to adjust losses shall be vested in the management committee as insurance trustee and to act consistent; with the insurance policy then in force.
- 9. Section 17 of the Declaration, entitled "Sale or Lease; Right of First Refusal" shall be eliminated from the Declaration.
- 10. Paragraph 21.1 is amended to read as follows:
 - 21.1 Except as otherwise provided in this declaration and except as prohibited by the act, the provisions of this declaration may be amended if Owners holding at least two-thirds (2/3) in the aggregate of ownership interest in the common areas and facilities consent and agree to such amendment by instruments duly recorded by the Management Committee in the Office of the County Recorder for Salt Lake County, Utah.
- 11. Paragraph 21.2 is amended to read as follows:

21.2 Unit owners may, by written agreement delivered to the management committee, transfer ownership of carports, parking spaces or storage spaces to other unit owners. Upon receipt of any such agreement, together with a fee to compensate the management committee for legal and recording expenses, in an amount to be determined by the management committee, the management committee shall amend Appendix A to reflect the change agreed to and cause said amendement to be recorded in the Office of the Salt Lake County Recorder.

12. Paragraph 22.6 is amended to read as follows:

22.6 In assessing the unit owners for capital improvements to the common areas and facilities, for which there are not sufficient amounts in the respective captital accounts, there shall be no single improvement exceeding the sum of Twenty Thousand Dollars (\$20,000) made by the management committee without the same having been first voted on and approved by two-thirds (2/3) majority of the association members present in person or by proxy at a meeting duly called for that purpose. The foregoing shall not apply in connection with damage or destruction referred to in paragraph 13 hereof.

13. Section 24 is amended to read as follows:

Any notice permitted or required to be delivered herein may be delivered provided personally or by certified mail. If delivery is made by mail, it shall be deemed to be delivered twenty-four (24) hours after a copy of the same has been deposited in the U.S. postal service, postage prepaid, return receipt requested. to unit owners shall be addressed to each unit owner at the address given by such unit owner to management committee for the purpose of service of such notice or to the unit of such unit owner if no such address has been given to the management committee. Such address may be changed from time to time by notice in writing to the Notice to the management management committee. committee shall be addressed to such address as designated by the management committee pursuant to paragraph 9.2 of the Declaration.






