The United States of America, To all to whom these presents shall come, Greeting:

Homestead Certificate No. 4240

Application 6573

Whereas there has been deposited in the General Land Office of the United States a Certificate of the Register of the Land Office at Salt Lake City Utah Territory whereby it appears that pursuant to the Act of Congress approved 20th May, 1862 to secure Homesteads to Actual Settlers on the Public Lands; and the Act supplemental thereto, the claim of William R. Martin has been established and duly consummated, in conformity to law, for the West half of the South West quarter of Section twenty four in Township five North of Range two West of Salt Lake Meridian in Utah Territory containing eighty acres according to the Official Plat of the Survey of the said Lands returned to the General Land Office by the Surveyor General:

Now know ye, That there is, therefore, granted by the United States unto the said William R. Martin the tract of land above described: To have and to hold the said tract of Land, with the appurtenances thereof, unto the said William R. Martin and to his heirs and assigns forever: subject to any vested and accrued water rights for mining, agricultural, manufacturing or other purposes, and rights to ditches and reservoirs used in connection with such water rights, as may be recognized and acknowledged by the local customs, laws and decisions of courts, and also subject to the right of the

proprietors of a vein or lode to extract and remove him or therefrom, should the same be found to penetrate or intersect the premises hereby granted as provided by law.

In testimony whereof I Benjamin Harrison President of the United States of America, have caused these letters to be made patent, and the seal of the General Land Office to be hereunto affixed.
