#### PARTIAL ASSIGNMENT AND ASSUMPTION AGREEMENT

(Development Agreement – Benloch Ranch)

This Partial Assignment and Assumption Agreement (this "Assignment") is effective as of <u>Japuary</u> 17, 2023 (the "Effective Date"), by and between WASATCH FRONT INVESTMENTS, LLC, a Wyoming limited liability company ("Assignor"), and CACHE PRIVATE CAPITAL DIVERSIFIED FUND, LLC, a Nevada limited liability company ("Assignee" or "Cache"), whose address is 2600 W. - B. Pursuant to that certain Partial Assignment and Assumption Agreement with an effective date of June 25, 2021, AJ Fireside assigned to Assignor, and Assignor assumed, certain right, title, and interest of AJ Fireside in 200 ERUs (as defined in the Agreement) within the real property conveyed by AJ Fireside to Assignor pursuant to that certain Special Warranty Deed filed in the Wasatch County Recorder's office as Entry No. 502779 (the "Cache Property").

- C. Pursuant to that certain Partial Assignment and Assumption Agreement with an effective date of September 15, 2021, Cache assigned to Assignor, and Assignor assumed, certain right, title, and interest of Cache in 25 ERUs (as defined in the Agreement) within the real property conveyed by Cache to Assignor pursuant to that certain Special Warranty Deed filed in the Wasatch County Recorder's office as Entry No. 507410, as more particularly described on Exhibit A (the "Property").
- D. On or about the date hereof, Assignee has acquired the Property from Assignor and Assignor and Assignee desire to enter into this Assignment to memorialize the transfer of the rights and obligations of 25 ERUs (as defined in the Agreement) (the "Transferred Density Units") as it relates to the Property.

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, Assignor and Assignee hereby agree as follows:

- 1. <u>Assignment</u>. Assignor hereby transfers, assigns, and conveys unto Assignee all right, title, and interest of Assignor in and to the Agreement as it relates to the Transferred Density Units and the Property.
- 2. <u>Assumption</u>. In consideration of the foregoing assignment, Assignee hereby assumes and agrees to pay, discharge, and perform the obligations of Assignor under the Agreement arising on and after the Effective Date as it relates to the Transferred Density Units and the Property.
- 3. <u>Binding Effect</u>. This Assignment shall inure to the benefit of and be binding upon the Parties and their successors and assigns.
  - 4. Governing Law. The laws of the State of Utah shall govern this Assignment.
