## ASSIGNMENT OF BENEFICIARY'S INTEREST IN DEED OF TRUST

THIS ASSIGNMENT OF BENEFICIARY'S INTEREST IN DEED OF TRUST (this "Assignment") is made as of the 14th day of June, 2010, by AMERICANWEST BANK, successor in interest to FAR WEST BANK and doing business as "FAR WEST BANK, a Division of AMERICANWEST BANK, Spokane, WA" ("Assignor"), and CIF SERVICES, LLC, a Nevada limited liability company ("Assignee").

### RECITALS

WHEREAS, DON MECHAM and CINDY MECHAM delivered to Assignor a Promissory Note dated September 29, 2006, in the original principal amount of \$1,000,000.00, which Note was amended by certain Change in Terms Agreements, dated September 25, 2007, February 7, 2008, August 28, 2008, October 28, 2008, July 16, 2009, and December 30, 2009, (the Promissory Note as amended is referred to herein as the "Note"), which Note was secured by a Revolving Credit Deed of Trust, dated September 29, 2006 (the "Deed of Trust") and recorded in the Office of the County Recorder of Utah County, Utah on October 2, 2006 as Entry No. 130544, against certain real property more particularly described on Exhibit "A" attached hereto (the "Property"); and

1. Assignor hereby irrevocably assigns, sets over, transfers and conveys to Assignee, effective as of the date first set forth above, all of Assignor's right, title and interest as beneficiary under the Deed of Trust and as payee under the Note.






