DECLARATION OF

COVENANTS, CONDITIONS AND RESTRICTIONS

OF

THE HAVENGROVE

PLANNED UNIT DEVELOPMENT PHASES I, II AND III

THIS AMENDMENT TO DECLARATION OF COVENANTS, CONDITIONS AND RESTRICTIONS is made and executed this 157-1 day of SEPTEMBER., 1992, by THE HAVENGROVE HOMEOWNERS ASSOCIATION (hereinafter referred to as the "Association").

RECITALS:

- A. On June 27, 1986, Wayne Pace Construction and Development Company as the Declarant recorded a Declaration of Covenants, Conditions and Restrictions of The Havengrove Planned Unit Development Phases I, II and III (hereinafter referred to as the "Declaration") as Entry No. 4268198 in Book 5783, pages 757 through 798 of the Records of the Salt Lake County Recorder.
- B. Pursuant to the provisions of Article X, Section 3 of the Declaration, the Association has amended the Declaration as hereinafter set forth.
- C. The Association desires to record this Amendment in compliance with the provisions of the Declaration.

NOW, THEREFORE, the Association hereby states as follows:

- 1. Article I, Section II of the Declaration is hereby amended to read as follows:
 - 11. Association shall mean and refer to The New Haven Homeowners Association, Inc., a Utah nonprofit corporation.
- 2. The foregoing amendments were approved by the Association at a meeting held on the 15TH day of MAY, 1992, for which notice was duly given. A quorum of Class A membership votes were present in person or represented by proxy. 8 of the Class A Votes present in person or represented by proxy were voted in favor of the amendments, and 6 to f the Class A votes present in person or represented by proxy were voted against the amendments.
