This matter came before the Court, the Honorable Sean M. Peterson presiding, for a jury trial on May 23, 24, 25 and 26, 2023. Plaintiff and Counterclaim Defendant, Arthur F. Jepperson, was represented by Michael Combs and Tyler Call of Hepworth Legal. Defendants and Counterclaim Plaintiffs, Dustin Harrow and Christie Harrow, were represented by Jeremy Sink of

Kirton McConkie. Pursuant to the Special Verdict Form completed by the Jury, which Special Verdict Form is incorporated herein by reference, Christie Harrow and Dustin Harrow were found innocent on Arthur Jepperson's defamation claim against them. Pursuant to the Special Verdict Form, Christie Harrow and Dustin Harrow were found innocent on Arthur Jepperson's claim of intentional infliction of emotional distress. Pursuant to the Special Verdict Form, Arthur Jepperson was found innocent on the Harrow's claim of intentional infliction of emotional distress. Pursuant to the Special Verdict Form, Arthur Jepperson was found guilty of defaming Dustin Harrow.

JUDGMENT

Consistent with the Special Verdict Form read onto the record on May 26, 2023, Judgment is hereby entered in favor of Defendant Dustin Harrow and against Arthur F. Jepperson in the amount of Four Hundred Fifty Thousand and 00/100 Dollars (\$450,000.00) with said judgment to accrue interest at the post judgment interest rate of 6.73% per annum from the date of entrance of this judgment until paid in full.
