The minimum term of said lease will be six (6) months, and renewable only for a like Subletting of property is not allowed. or longer period. photo copy of the signed lease document must be provided to the Board of Directors or to an Officer of the Association.

The lessee must fulfil the age requirements of the Association, and the lessor or his agent will obtain from the lessee, or prospective lessee, a copy of proof of the lessee's age, showing he or she to be 55 years of age or older.
