

A portion of the Northwest Quarter (NW 1/4) and the Northeast Quarter (NE 1/4) of Section 28, Township 42 South, Range 15 West, Salt Lake Base and Meridian, located in St. George City, Washington County, State of Utah, more particularly described as follows:

BEGINNING at a point on the South boundary of "Cheyenne at Red Cliffs Phase 1"; located South 00° 30' 47" East along the Quarter (1/4) section line 940.92 feet and North 89° 58' 47" West 165.63 feet from the North Quarter (N1/4) Corner of Section 28, Township 42 South, Range 15 West, Salt Lake Base and Meridian; thence South 00° 01' 13" West 847.67 feet; thence South 54° 01' 54" East 126.59 feet; thence North 27° 10' 29" East 28.00 feet; thence South 74° 26' 26" East 92.77 feet to a point on a 270.00 foot radius curve at the Westerly line of 2000 East Street; thence Southwesterly along the arc of said 270.00 foot radius curve 42.83 feet (Chord: South 20° 06' 13" West 42.78 feet); thence South 65° 21' 08" East 60.00 feet to a point on a 330.00 foot radius curve at the Easterly line of 2000 East Street, the previous (6) courses along the boundary of said "Cheyenne at Red Cliffs Phase 1"; thence Southwesterly along the arc of said 330.00 foot radius curve 207.91 feet (Chord: South 42° 41' 48" West 204.49 feet) to a point of tangency; thence South 60° 44' 43" West 40.94 feet to a point of curvature; thence Southwesterly along the arc of a 30.00 foot radius curve 44.88 feet (Chord: South 18° 03' 32" West 40.81 feet) to the Northeasterly line of Mall Drive; thence South 60° 44' 43" West 80.00 feet to the Westerly line of Mall Drive; thence North 29° 15' 17" West 1013.81 feet to a point of curvature; thence Northwesterly along the arc of 540.00 foot radius curve to the right 275.72 feet (Chord: North 14° 37' 38" West 272.73 feet) to a point of tangency; thence North 87.16 feet to a point on the Southerly boundary line of "Santa Fe at Red Cliffs Phase V", the previous (3) Courses along the Westerly line of said Mall Drive; thence East along said Phase V 80.00 feet to the Easterly line of Mall Drive and the Southwest Corner of "Cheyenne at Red Cliffs Phase 1"; thence South 89° 58' 47" East along the South line of said plat 497.00 feet to the point of beginning.
