THIS AGREEMENT, made this 28th day of July A.D. 1925, by and between FRANK W. FOULGER and CLEOPA F. FOULGER his wife and J. W. FOULGER & Esmerelda Foulger, parties of the first part, and SALT LAKE CITY, a municipal corporation of the State of Utah, party of the second part,

WITNESSETH:

THAT WHEREAS, parties of the first part have constructed two dwelling houses on the following described real property, situate, and lying and being in Salt Lake City, Salt Lake County, State of Utah, to-wit:
The west half of Lots 10 and 11, Block 3, Columbia Subdivision, of Lot 20, Block 22, Five Acre Plat "A", Big Field Survey.

AND WHEREAS, Salt Lake City under date of May 16th, 1924 passed an ordinance relating to sewers and known as Section 1677x1, which ordinance is hereby referred to, incorporated herein and made a part hereof;

WHEREAS, the Board of Commissioners of Salt Lake City upon the recommendation of its City Engineer will permit both of said dwellings to be connected to the main line sewer lateral upon the parties of the first part, executing an agreement to conform with the provisions of said Section 1677x1 herein referred to.

NOW THEREFORE, in consideration of Salt Lake City granting permission to connect both of said dwelling houses to the same lateral, the party of the first part hereby agrees that in the event of said dwelling houses being sold or disposed of separately, the grantee shall have a perpetual easement over and through the above described premises for the purpose of constructing, maintaining and operating each separate sewer connection, and the separate owners shall have the easement running with the land for the purpose of maintaining said sewer as aforesaid, and that the owners of said property shall bear and pay their proportionate share for the maintenance and repair of said sewer connection whether the expenditure, maintenance or repair is or becomes necessary upon their own premises or upon the premises with which they are connected.
