**ERRATA TO THE  
FIRST AMENDMENT TO THE MASTER DECLARATION  
OF EASEMENTS, COVENANTS AND RESTRICTIONS  
FOR THE BLACK ROCK RIDGE COMMUNITY**

This ERRATA to the FIRST AMENDMENT to the MASTER DECLARATION OF EASEMENTS, COVENANTS AND RESTRICTIONS FOR THE BLACK ROCK RIDGE COMMUNITY (this "Errata") is executed by the Black Rock Ridge Master Homeowners Association, Inc., a Utah non-profit corporation (the "Association").

**RECITALS**

A. The MASTER DECLARATION OF EASEMENTS, COVENANTS AND RESTRICTIONS FOR THE BLACK ROCK RIDGE COMMUNITY was recorded in the Wasatch County Recorder's Office on July 12, 2012, as Entry No. 380463 in book 1059, pages 289-349 (the "Master Declaration").

B. The By-laws of Black Rock Ridge master Homeowners Association, Inc. (the "Bylaws") were attached to and recorded with the Master Declaration as Exhibit B thereto.

C. The First Amendment to the Master Declaration of Easements, Covenants and Restrictions for the Black Rock Ridge Community (the "First Amendment") was recorded in the Wasatch County Recorder's Office on August 22, 2023, as Entry no. 535853, Bk 1451, Pages 256-276.

D. The Master Declaration and the First Amendment affect certain real property located in Wasatch County, Utah, more particularly described in Exhibit A (referred to herein as the "Project"), which is attached hereto and incorporated by reference.

E. The Project is operated and maintained by the Management Committee for the Black Rock Ridge Master Homeowners Association, Inc., a Utah nonprofit corporation (the "Master Association").

F. Pursuant to the Master Declaration, the membership of the Master Association is comprised of the owners of the Master Association's two sub-associations: the Black Rock Ridge Condo Owners Association, Inc., and the Black Rock Ridge Townhome Owners Association, Inc (collectively, the "Sub-associations").

G. This First Amendment was adopted to announce the expiration of the Declarant's rights to management within the Master Association and to revise the size and makeup of the Management Committee.

H. In preparing the First Amendment, the Management Committee intended to replace Article IV, Section 4.8, of the Master Declaration in its entirety. However, the recorded version of the First Amendment states that only the last sentence of the section was amended. Section 4.8 of the Master Declaration must be corrected to eliminate ambiguity and confusion in the drafted language.

I. Pursuant to Section 57-3-106(9) of the Utah Code, this Errata serves to correct the minor typographical or clerical errors in the First Amendment by making it clear that Section 4.8 of the Master Declaration has been replaced in its entirety.

### **ERRATA TO FIRST AMENDMENT**

**NOW, THEREFORE**, the First Amendment is hereby corrected to state as follows:

**Article IV, Section 4.8 of the Master Declaration is hereby amended to read as follows:**

4.8 4.8 Management Committee. The Management Committee (also known as the "Board of Trustees" or the "Board") shall be comprised of five (5) or seven (7) Trustees, one of which will be appointed from among the board of trustees of the Black Rock Ridge Condo Owners Association, Inc. (the "Condo Owners Association"), and one of which will be appointed from among the board of trustees of the Black Rock Ridge Townhome Owners Association, Inc. (the "Townhome Owners Association). Additionally, the Condo Owners Association will vote for two people from among its owners to serve as the third and fourth Trustees on the Management Committee and the Townhome Owners Association will vote for two people from among its owners to serve as the fifth and sixth Trustees. The seventh Trustee will be appointed by a joint decision made by the board of trustees of both the Condo Owners Association and the Townhome Owners Association. If the Management Committee is unable to identify seven individuals willing to serve as Trustees, then the Condo Owners Association and the Townhome Owners Association will each vote for only one person from the ownership of each sub-association (instead of two from each) to serve as Trustees on the Management Committee, for a total of five Trustees.

**The following section, Article XI, Section 11.19 of the Master Declaration, is hereby added to the Master Declaration as follows:**

11.19 Expiration of Declarant's Rights. Any and all rights and obligations reserved to the Declarant in the Master Declaration, Bylaws, or any other governing documents for the Master Association expired on or before July 12, 2022. Accordingly, any such rights or obligations in the governing documents shall be considered expired and shall have no further effect.

**IN WITNESS WHEREOF**, the President of the Master Association hereby executes this Amendment as of the date below and verifies that this Errata was adopted properly pursuant to the terms of the Master Declaration.

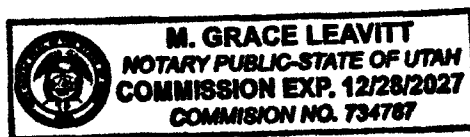
