EASEMENT

Welby Young, Grantor of Heber, County of Wasatch, State of Utah, hereby license and permit the State Road Commission of Utah, Licensee, for the sum of Twenty Five and no/100 Dollars to use the following described premises situated upon the grantor's land, in Wasatch County, Utah, for the purpose of constructing thereon an Irrigation ditch and appurtenant parts thereof;

A strip of ground 6 ft. wide, the center line of which begins at a point which is 43' West of Sta. 116/39 "A" line survey of W.P.H. 42-A of the State Road Commission thence N 31°59' west for 939 ft. to a point 43ft. west of station 125 + 78 of said survey. This land is in the SW. 1/4 of S.W. 1/4 and N.W. 1/4 of Sec. 20. T. 3 So. R 5 E. S.L.B. & M.

After said Ditch is constructed on above described premises at the expense of Licensee, said Licensee is thereafter relieved of any further claim or demand for costs, damages or maintenance charges which may accrue against said Ditch or appurtenant parts thereof.
