AMENDED DEFAULT JUDGMENT

THIS MATTER came before the Court on the Plaintiff's Motion for Default Judgment. A default judgment was previously entered on March 8, 2021, and is amended in its entirety by this judgment. The Court, having reviewed Plaintiff's motion, Complaint, and Declaration of Danny Blackburn, finds as follows:

- 1. Defendant was served with the Summons and Complaint on February 5, 2021, but failed to respond or appear within the time required. A Default Certificate was entered on March 2, 2021.
- 2. Plaintiff has verified the allegations contained in the Complaint, and through his declaration, has established that he paid \$21,000 to Defendant, but never received the promised

battery (for a solar-power system for his residence) and Defendant has failed to return the \$21,000 or even respond to Plaintiff's correspondence.

3. As Plaintiff's claim is for breach of contract, the legal rate of 10% interest as provided in Utah Code Ann. § 15-1-1 applies.

IT IS THEREFORE ORDERED that Plaintiff's Motion for Default Judgment is GRANTED, and the Court awards damages to Plaintiff totaling \$21,000 plus interest of 10% per annum. Judgment is hereby entered against Defendant as follows:

- A. The judgment creditor is Danny Blackburn.
- B. The judgment debtor is Brian Middleton, d/b/a My Off-Grid Power, d/b/a Utah Trailer & Repair.
- C. The address where Defendant was served with process is 2478 West 7625 South, West Jordan, Utah 84084.
- D. Plaintiff does not have personal knowledge of Defendant's birthdate or social security number.
- E. The total judgment entered against Defendant is \$21,000 principal, with 10% interest per annum until paid in full.
- F. As this is an amended judgment, and notice was given to the Defendant of the prior judgment, the Court finds that the delay in execution provided in Utah R. Civ. P. 62(a) need not apply, so the judgment may be enforced immediately after the entry of this amended judgment.
 - G. This is the final judgment in accordance with Utah R. Civ. P. 54(b) and 55.
