## SEWER EASEMENT

## KNOW ALL MEN BY THESE PRESENTS:

That in consideration of One Dollar (\$1.00) and other good and valuable consideration paid to: Little Valley Properties, L.L.C., hereinaster referred to as GRANTOR, by the City of St. George, hereinaster referred to as GRANTEE, the receipt of which is hereby acknowledged, the GRANTOR does hereby grant, transfer, and convey unto the GRANTEE, its successors and assigns, a temporary easement with the right to erect, construct, install and lay, and thereafter a perpetual easement to use, operate, inspect, repair, maintain, replace or remove sewer facilities and associated structures and service roads under, over, across and through the land owned by GRANTOR, or in which GRANTOR claims any interest, situated in Washington County, State of Utah, and affected by the legal description herein, together with the right of ingress and egress over the adjacent lands of the GRANTOR, his successors and assigns, for the purposes of this agreement.

A 30.00 foot wide permanent casement (15.00 feet each side of centerline) and a 50.00 foot wide temporary construction easement (25.00 feet each side of centerline), the centerline of both the temporary and perpetual easements is described in Exhibit "A", attached hereto and incorporated herein by this reference.

The consideration hereinabove recited shall constitute payment in full for the above-mentioned easement. The GRANTEE covenants to restore the easement to its original condition and to maintain the easement in good repair so that no unreasonable damage will result from its use to the adjacent land of the GRANTOR his successors and assigns.

The GRANTOR agrees not to place any structures within the easement described herein.
