EXHIBIT "A"

TRACT 1: The southeast quarter of Section 14, Township 5 South, Range 2 West of the Salt Lake Base and Meridian. Area 160 acres, more or less. *Gen*

Subject to easements of record and on the land, oil and mineral leases, and three-fourths of the crops now planted and growing on said land. Reserving to FREDA PETERSON one-half of the oil, gas and mineral rights to said land.

TRACT 2: All of the North one half; and all of the South West 1/4 of Section 35, Township 5 South, Range 2 West, Salt Lake Meridian. Area 480 Acres.

Less the Right of Way of U.P.R.R. area 21.20 acres. Said Right of Way being 4.00 Acres in the N.W. 1/4 of the N.E. 1/4; 13.80 acres in the N.W. 1/4; and 3.40 acres in the N.W. 1/4 of the S.W. 1/4. Area conveyed 458.80 acres. *Below Tracts*
