

ORDINANCE NO. 1-10-1997

VACATING ROADWAY

BE IT ORDAINED by the City Council of the City of St. George:

Petition having been received by this Council pursuant to Sec. 10-8-8.1, UCA, praying that a portion of Main Street be abandoned; and

The owners of all property abutting or directly affected by the portion of street proposed to be vacated having signed written consent thereto; and

The owners requesting vacation of the roadway have agreed to execute a road dedication plat granting to the City additional property for roadway purposes to replace that being vacated hereunder; and

It appearing that it will not be detrimental to the general interest and that there is good cause for vacation of said street described as follows:

See Exhibit "A" attached

Be and the same is hereby vacated.

Provided, however, that the City retains all easement rights within the vacated roadway to maintain, operate, repair and replace any poles, wires, pipes, conduits, sewer mains, water mains, drainage or any utility within the street portion thereof vacated by this ordinance.

This ordinance shall become effective upon compliance with the above conditions and upon publication in the manner required by Title 10, Chapter 3, Utah Code Annotated.

THENCE N 89°28'00" W, 7.00 FEET;

THENCE N 00°10'00" E, 1381.32 FEET TO A POINT OF A 1365.394 FOOT RADIUS  
NON-TANGENT CURVE TO THE RIGHT, THE RADIUS POINT OF WHICH BEARS  
(S 57°38'05" E); THENCE ALONG THE ARC OF SAID CURVE 40.92 FEET, (CHORD:  
N 33°13'26" E, 40.92 FEET);

THENCE N 34°04'57" E, 572.59 FEET, TO A POINT ON A 2331.60 FOOT RADIUS  
CURVE TO THE LEFT AND THE WESTERLY RIGHT-OF-WAY LINE OF SAID

MAIN STREET, THE RADIUS POINT OF WHICH BEARS (S 58°31'44" E);

THENCE ALONG THE WESTERLY RIGHT-OF-WAY LINE OF SAID MAIN  
STREET, AND THE ARC OF SAID CURVE 418.90 FEET, (CHORD: S 26°19'27" W,  
418.34 FEET);

THENCE S 21°11'37" W, 41.91 FEET TO THE POINT OF BEGINNING.
