EASEMENT AGREEMENT.

THIS AGREENENT, made this 14 day of May A. D. 1926 by and between C. A. Woolley Building Co. party of the first part, and Salt Lake City, a municipal corporation of the State of Utah, party of the second part, WITNESSETH:

THAT WHEREAS, party of the first part has constructed 5 dwelling houses on the following described real property, situated, lying and being in Salt Lake City, Salt Lake County, State of Utah, to-wit: Lot 7, Block 16, Plat "B", Salt Lake City Survey.

AND WHEREAS, SALT LAKE CITY under date of May 16, 1924, passed an ordinance relating to sewers and known as Section 1677Xl, which ordinance is hereby referred to, incorporated herein and made a part hereof;

WHEREAS, the Board of Commissioners of Salt Lake City upon the recommendation of its City Engineer will permit said dwellings to be connected to the main line sewer lateral upon the parties of the first part, executing an agreement to conform with the provisions of said Section 1677X1, herein referred to.

NOW THEREFORE, in consideration of Salt Lake City granting permission to connect said dwellings to the same lateral, the party of the first part hereby agrees that in the event of said dwelling houses being sold or disposed of separately, the grantee shall have a perpetual easement over the following right-of-way: Commencing 68 feet south of the northeast corner of Lot 7, Block 16, Plat "B" Salt Lake City Survey and running thence West 330 feet, thence South 25 feet, thence East 330 feet thence North 25 feet to the place of beginning, and also over the property Described as follows: Commencing 35 feet East of the Southwest corner of said Lot 7, Block 16, Plat "B", and running thence East 5 feet, thence North 69 feet, thence West 5 feet, thence South 69 feet to place of beginning, for the purpose of constructing, maintaining and operating a sewer lateral. The separate owners shall have the easement running with the land for the purpose of maintaining said sewer as aforesaid and that the owners of said property shall bear and pay their proportionate share for the maintenance and repair of said sewer lateral,

And the said Salt Lake City shall also have the right to construct and maintain a water main with

service connections over the aforesaid right-of-way.
