## RESCISSION AND RELEASE OF AMENDED DECLARATION OF PROTECTIVE COVENANTS, CONDITIONS AND RESTRICTIONS OF ALTA VIEW ESTATES HOMEOWNERS ASSOCIATION Sandy, Utah

THIS RESCISSION AND RELEASE made this 29th day of October, 1993 by ALTA VIEW ESTATES HOME OWNERS

ASSOCIATION ("Association"). This rescission is intended to rescind the Amended Declaration of Protective Covenants, Conditions, and Restrictions of the Alta View Estates Homeowners Association, recorded with the Salt Lake County Recorders Office on the 9th day of July, 1993.

WHEREAS, the Association has heretofore adopted an Amended Declaration of Protective Covenants, Conditions, and Restrictions; and

WHEREAS, the Association has previously recorded the Amended Declaration of Protective Covenants, Conditions, and Restrictions; and

WHEREAS, the Association has now determined through a further review of the voting on the Amended Declaration of Protective Covenants, Conditions, and Restrictions that said Amended Declaration did not receive a sufficient number of votes to pass.

NOW THEREFORE, the Association declares that the real property located in Sandy City, Salt Lake County, State of Utah, more particularly described in Exhibit "A" attached hereto is and shall be released from the Amended Declaration of Protective Covenants, Conditions, and Restrictions recorded with the Salt Lake County Recorders Office on the 9th

day of July, 1993, and that said Amended Declaration of Protective Covenants, Conditions, and Restrictions are hereby completely rescinded and invalidated due to the lack of a sufficient majority vote of the members of the Association to make said Declaration valid.
