ROADWAY DESCRIPTIONS

MAIN STREET

A PORTION OF SECTION 6, TOWNSHIP 43 SOUTH, RANGE 15 WEST, SALT LAKE BASE AND MERIDIAN,
MORE PARTICULARLY DESCRIBED AS FOLLOWS:

COMMENCING AT THE NORTHWEST CORNER OF SECTION 6, TOWNSHIP 43 SOUTH, RANGE 15 WEST, SALT
LAKE BASE AND MERIDIAN;
THENCE N 89°28'23" E ALONG THE SECTION LINE 1285.30 FEET TO THE POINT OF BEGINNING;
THENCE S 34°02'49" W 120.07 FEET TO THE POINT OF CURVATURE OF A 2331.60 FOOT RADIUS CURVE
TO THE LEFT, THE RADIUS POINT OF WHICH BEARS S 55°57'11" E);
THENCE SOUTHWESTERLY ALONG THE ARC OF SAID CURVE 523.07 THROUGH A CENTRAL ANGLE
OF 12°51'13" TO THE POINT OF TANGENCY;
THENCE S 21°11'37" W 164.38 FEET TO A POINT OF CURVATURE OF A 1333.00 FOOT RADIUS CURVE TO
THE LEFT;
THENCE SOUTHWESTERLY ALONG THE ARC OF SAID CURVE 489.19 FEET TO A POINT OF TANGENCY (CHORD:
S 10°40'48" W 486.45");
THENCE S 00°10'00" W 953.13 FEET;
THENCE S 89°50'00" E 33.00 FEET;
THENCE N 00°10'00" E 75.99 FEET;
THENCE S 89°50'00" E 33.00 FEET;
THENCE N 00°10'00" E 877.14 FEET, TO A POINT OF CURVATURE OF A 1267.00 FOOT RADIUS CURVE TO
THE RIGHT THE RADIUS POINT OF WHICH BEARS (S 89°50'00" E);
THENCE NORTHEASTERLY ALONG THE ARC OF SAID CURVE 464.97 FEET THROUGH A CENTRAL ANGLE OF
21°01'37" TO THE POINT OF TANGENCY;
THENCE N 21°11'37" E 164.38 FEET, TO A POINT OF CURVATURE OF A 2265.60 FOOT RADIUS CURVE TO
THE RIGHT;
THENCE NORTHEASTERLY ALONG THE ARC OF SAID CURVE 508.26 FEET, THROUGH A CENTRAL ANGLE OF
12°51'13", TO THE POINT OF TANGENCY;
THENCE N 34°02'49" E 116.71 FEET;
THENCE N 00°02'08" E 83.72 FEET TO A POINT ON THE ARC OF A 1103.93 FOOT RADIUS NON-TANGENT
CURVE TO THE LEFT, (A RADIAL LINE WHICH BEARS N 73°12'34" W), SAID POINT BEING ON THE WESTERLY
RIGHT-OF-WAY LINE OF A HIGHWAY FRONTAGE ROAD;
THENCE ALONG THE ARC OF SAID CURVE 59.50 FEET, THROUGH A CENTRAL ANGLE OF 03°15'17";
THENCE S 34°02'49" W 122.35 FEET TO THE POINT OF BEGINNING.

1670 SOUTH STREET

A PORTION OF SECTION 6, TOWNSHIP 43 SOUTH, RANGE 15 WEST, SALT LAKE BASE AND MERIDIAN,
MORE PARTICULARLY DESCRIBED AS FOLLOWS:

COMMENCING AT THE NORTH WEST CORNER OF SAID SECTION 6;
THENCE N 89°28'23" E ALONG THE SECTION LINE 2062.68 FEET;
THENCE SOUTH 567.40 FEET TO THE POINT OF BEGINNING;
THENCE N 89°03'43" W 841.92 FEET TO A POINT OF CURVATURE OF A 268.75 FOOT RADIUS CURVE TO
THE RIGHT;
THENCE ALONG THE ARC OF SAID CURVE 102.45 FEET TO A POINT OF TANGENCY. (CHORD: N78°00'27"
W 101.83 FEET);
THENCE N 67°13'12" W 34.48 FEET TO A POINT OF CURVATURE OF A 20.00 FOOT RADIUS CURVE TO
THE RIGHT;
THENCE ALONG THE ARC OF SAID CURVE 27.95 FEET TO THE POINT OF CUSP, THE RADIUS POINT OF WHICH
BEARS (S77°09'41" E)
SAID POINT BEING ON THE ARC OF A 2265.60 FOOT RADIUS CURVE, SAID POINT ALSO BEING ON THE
EASTERLY RIGHT-OF-WAY LINE OF MAIN STREET, THE RADIUS POINT OF WHICH BEARS (S66°09'50"E)
THENCE SOUTHWESTERLY ALONG THE ARC OF SAID CURVE & EASTERLY RIGHT-OF-WAY LINE 96.34
FEET TO THE POINT OF CUSP, THROUGH A CENTRAL ANGLE OF 02°26'11" THE RADIUS POINT OF WHICH
BEARS (S66°35'52"E 20.00 FEET);
THENCE NORTHEASTERLY ALONG THE ARC OF A 20.00 FOOT RADIUS CURVE TO THE RIGHT 31.20 FEET,
THROUGH A CENTRAL ANGLE OF 89°22'41"
THENCE S 67°13'12" E 33.90 FEET TO THE POINT OF CURVATURE OF A 328.75 FOOT RADIUS CURVE TO
THE LEFT; THENCE ALONG THE ARC OF SAID CURVE 125.32 FEET, (CHORD: S 78°08'27" E 124.57
FEET) TO A POINT OF TANGENCY;
THENCE S 89°03'43" E 335.90 FEET;
THENCE N 00°56'17" E 30.00 FEET;
THENCE S 89°03'43" E 506.02 FEET;
THENCE N 00°56'17" E 30.00 FEET TO THE POINT OF BEGINNING.
