TOGETHER with all easements, rights, and hereditaments appurtenant thereto and all improvements located thereon.



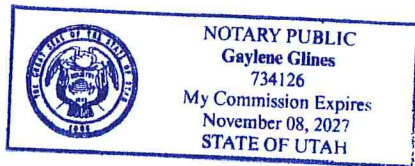
