Trustor hereby CONVEYS AND WARRANTS TO TRUSTEE IN TRUST, WITH POWER OF SALE, the following
 described property situated in Salt Lake County, Utah:

Beginning 660.5 feet North from the Southeast Corner of Section 31, Township 2
 South, Range 1 East, Salt Lake Base and Meridian; and running thence North 107.5
 feet; thence West 220 feet; thence South 107.5 feet; thence East 200 feet to the
 point of beginning.

Together with all buildings, fixtures and improvements thereon and all water rights, rights of way, easements, rents,
 issues, profits, income, tenements, hereditaments, privileges and appurtenances thereunto now or hereafter used or
 enjoyed with said property, or any part thereof;

 said property, to pay all costs and expenses of collection (including Trustee's and attorney's fees in event of default in

 Trustee hereunder, including a reconveyance hereof.

 him at the address hereinbefore set forth.

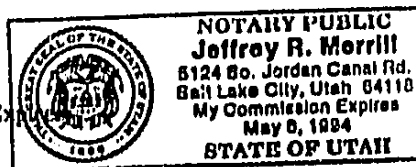
