ORDINANCE VACATING A PUBLIC UTILITY EASEMENT ON LOTS 16 AND 17 IN THE OLD FIELD INDUSTRIAL SUBDIVISION

WHEREAS, when the original Old Field Industrial subdivision dedicated public utility easements along the frontage of lots 16 and 17; and

WHEREAS, the street right of way where the original public utility easements were located along lots 16 and 17 was vacated by Cedar City Ordinance 0312-08; and

WHEREAS, the public utility easement should have been vacated when the road was vacated; and

WHEREAS, The City Council of Cedar City, Utah, met in regular session and has determined that it would be appropriate to vacate the following described public utility easement along lots 16 and 17 of the Old Field Industrial Subdivision, Cedar City, County of Iron, State of Utah, which the City does hereby vacate and release:
