AMENDMENT TO EASEMENT

This Amendment to Easement ("Amendment") made this 27 day of October, 1993 by and between Amoco Pipeline Company, a Maine Corporation with an office located at One Mid America Plaza, Suite 200, Oakbrook Terrace, IL 60181, its successors and assigns, hereinafter called "Grantee", and Rocky Mountain Fabrication  
P.O. Box 16409, Salt Lake City, Utah 84116

WHEREAS, Grantor (or Grantor's predecessor in interest) granted to Grantee an easement ("Easement") on, over, and through certain property located in Salt Lake County, State of Utah, Township 1 North, Range 1 West, Section 14, the SW 1/4, to-wit:

See Exhibit "A" attached hereto and incorporated by reference herein.

WHEREAS, aforesaid Easement was recorded in the Salt Lake County Recorder's Office on April 8, 1991 in Book 6304, Pages 1199-1203, as Document Number 5048678, and

WHEREAS, Grantor and Grantee desire to modify said Easement.

NOW, THEREFORE, in consideration of Fifty dollars (\$2250.00),  
in hand paid, the receipt and sufficiency of which is hereby  
acknowledged by Grantee, it is hereby agreed as follows:

1. The Easement is hereby amended and modified to provide that the Grantee shall have the right to construct, operate, inspect, maintain, protect, mark, relocate, repair, replace, change the size of, and remove one (1) additional pipeline to be constructed within the original Easement right of way grant alongside the pipeline constructed under original Easement grant. Accordingly, Grantee shall have the right to maintain, operate, etc., a total of two (2) pipelines within the original Easement right of way.

2. Except as specifically modified above, all terms and conditions of the Easement shall remain in full force and effect.




