TO ALL TO WHOM THESE PRESENTS SHALL COME, GREETING:

WHEREAS, SAMUEL STARK of Salt Lake City of the County of SALT LAKE State of UTAH heretofore purchased from the State of Utah, the lands hereinafter described, pursuant to the laws of said State in such case made and provided;

AND WHEREAS, the said SAMUEL STARK has paid for said lands, pursuant to the conditions of said sale and the laws of the State duly enacted in relation thereto, the sum of FOUR HUNDRED AND NO/100 (\$400.00) Dollars, and all legal interest thereon accrued, as fully appears by the certificate of the proper officer, now on file in the office of the Secretary of State of the State of Utah;

NOW THEREFORE, I, SIMON BAMBERGER, Governor, in consideration of the premises, and by virtue of the power and authority vested in me by the laws of the State of Utah, in such case made and provided, do issue this PATENT, in the name and by the authority of the State of Utah, hereby granting and confirming unto the said SAMUEL STARK and to his heirs and assigns forever, the following piece or parcel of land, situate in the County of Utah State aforesaid, to wit:

The West Half (W 1/2) of the Northwest quarter (NW 1/4) and the West Half (W 1/2) of the Southwest quarter (SW 1/4) of Section Eight (8) in Township Six (6) South, Range Two (2) West of the Salt Lake Meridian, containing ONE HUNDRED SIXTY (160) acres according to the said certificate;

TO HAVE AND TO HOLD the above described and granted premises unto the said SAMUEL STARK and to HIS HEIRS and assigns forever, subject to any easement or right of way as may have been established or acquired according to law, over the same or any part thereof, and subject also to all rights of way for ditches, tunnels, and telephone and transmission lines that may have been constructed by authority of the United States.

IN TESTIMONY WHEREOF, I have hereunto set my hand and caused the great seal of the State of Utah to be hereunto affixed.

DONE at Salt Lake City, this 26th day of JULY in the year of our Lord, one thousand nine hundred and TWENTY, and of the independence of the United States of America the one hundred and FORTY FOURTH and in the TWENTY FIFTH year of the State of Utah.

WHEREAS, a Certificate of the Register of the Land Office at Salt Lake City, Utah, has been deposited in the General Land Office, whereby it appears that, pursuant to the Act of Congress of May 20, 1862, "To Secure Homesteads to Actual Settlers on the Public Domain," and the acts supplemental thereto, the claim of George S. Barnum has been established and duly consummated, in conformity to law, for the South half of the southwest quarter and the south half of the southeastquarter of Section twenty-one, the south half of the southwest quarter
