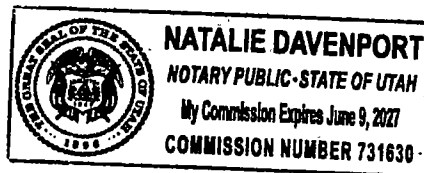

Date**RIGHTS OF APPEAL**

You have the right to appeal this Notice of Violation by requesting an Administrative Hearing before an Administrative Hearing Officer within ten (10) days from the date this Notice of Violation was issued. If the Notice was mailed, the request must be made within fourteen (14) days. The request must be made in writing using the prescribed appeal form available online at <https://provo.org> or at 445 W Center Street Suite 200. You may deliver or mail the appeal form to the Provo City Development Services Zoning Division at 445 W Center Street Suite 200, Provo, Utah 84601. Filing an appeal will result in an Administrative Hearing which you should attend. You may choose to be represented by an agent or attorney at the hearing although it is not required. An attorney will not be appointed for you. If you request a hearing and are found responsible for the violation(s) for which you were cited, you will be liable for ALL costs and expenses associated with the hearing including, but not limited to a \$100.00 Administrative Hearing Fee.
