RIGHT OF WAY DEED.

John C. Demopulos, (Unmarried), grantor, of Mohrland, County of Emery, State of Utah, hereby grants, bargains and sells to the STATE ROAD COMMISSION OF UTAH, Grantee, for the sum of (\$3.00) Three & No/100 DOLLARS, the following described right of way across the grantor's land in Davis County, State of Utah, as follows:

Right of way for highway known as N.R.H. Project No. 111-A across the grantor's land in Lot 15, Cudahy Tract - NE $\frac{1}{4}$ of Section 11, T. 1 N., R. 1 W., S.L.B. & M. Said right of way is contained within a strip of land 50 ft. wide, 50 ft. on the northwesterly side of the center line of survey of said project, the boundaries of which are more particularly described as follows:

Beginning at the southeast corner of said lot 15, which point is 41.25 ft. N. 68° 27' W. from Engr's Sta. 67/50.5 of the survey of said project; thence N. 68° 27' W., along the southerly boundary line of said lot 15, 8.75 ft.; thence N. 21° 33' E., parallel to and 50 ft. perpendicularly distant from said center line of survey, 65.0 ft. to the northerly boundary line of said lot 15; thence S. 68° 27' E. 8.75 ft. to the northeast corner of said lot 15; thence S. 21° 33' W., 65.0 ft. to the point of beginning as shown on the official map of said project on file in the office of the State Road Commission of Utah. Above described tract of land contains approximately 0.01 acres.

As part of the consideration for the above described highway right of way, the grantor hereby gives to the State Road Commission of Utah permission to relocate and reconstruct, within the grantor's land, and outside the limits of the above described right of way, any irrigation ditches existing within said limits of above described right of way.

The purpose of this deed is to grant a perpetual right of way for highway purposes.
