Witness the hand of said grantor by and through its duly elected and authorized trustees, this 23 day of August, 1994.

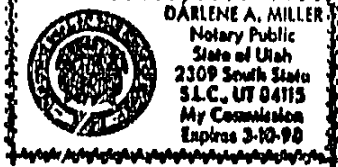
