Right Of Way Deed

Nekkie Gibson (widow) and P.T. Nelson hife Est. grantors
 of Troy, County of ~~Utah~~ Weber State of Utah,
 hereby grant, bargain and sell to the STATE ROAD COMMISSION OF UTAH, Grantee, for the
 sum of (80.00) Eighty ⁰⁰/₁₀₀ DOLLARS,
 the following described right of way across the grantors' land in Weber County,
 State of Utah, as follows:

Right of way for highway known as F. A. Project No. 114-E across the grantors land in the NW $\frac{1}{4}$ NW $\frac{1}{4}$ of Section 24, T. 5 N., R. 2 W., S. L. M. Said right of way is contained within a parcel of land 50 ft. wide, 50 ft. on the east side of the center line of survey of said project. Said center line is described as follows:

Beginning at the intersection of the south boundary line produced of said grantors land and said center line of survey at Engineer's Station 414+17, which point is 797.5 ft. south along the west line of said Section 24, from the northwest corner of said Section 24; thence N. 0° 10' E., 59 ft. to the intersection of said center line of survey at Engineer's Station 414+76 and the north boundary line produced of said grantors land, which point is 738.5 ft. south along said west section line from said northwest corner of Section 24, as shown on the official map of said project on file in the office of the State Road Commission of Utah. Above described parcel of land contains 0.07 acre, of which 0.05 acre is now occupied by the existing highway. Balance 0.02 acre.

In executing this deed, the grantors hereby grant to the State Road Commission of Utah permission to relocate and reconstruct within the grantors land and outside the limits of above described right of way, all irrigation ditches existing within said limits of above described right of way and to extend onto said grantors land and outside the limits of the above described right of way, all cut and/or fill slopes made necessary by the grading for sidewalks on said project.

The purpose of this deed is to grant a perpetual right of way for highway purposes.
