All certifications provided for in this section shall be in such form as will enable them to be recorded with the Recorder of Salt Lake County, Utah.

WHEREAS, the Developer has completed the Improvements (as defined in the

A.D.L.) in accordance with those provisions of the A.D.L., and the Developer desires the
