The undersigned, being a majority of the record title holders of the Louise Gardens No. 1 Subdivision, Lots 1-25, inclusive, do hereby consent and agree, in its entirety, to:

- Nullify and void, in its entirety, the "Amendment to Conditions and Restrictions", recorded in the Salt Lake County Recorder's office on November 13, 1980, at 4:05 p.m. With nullification and voiding, consent is granted to return Lots 5, 6 and 7, Louise Gardens No. 1, to the original "Restrictions and Protective Covenants for Louise Gardens Subdivision, Salt Lake County, Utah", as recorded April 20, 1956 at 2:08 p.m.
- Delete all language and references to "one and one-half story height restrictions" and replace said references and language, item #4 of Covenants, to the following:
 - "That no lot shall be used except for residential purposes. No building shall be erected, altered, placed, or permitted to remain on any lot other than one detached single-family dwelling not to exceed one story in height and a private garage for not more than three cars."
- 3. All language and references to the "architectural control committee" membership, item #5 of Covenants, which defines the membership of the "architectural committee", in regard to who those members are composed of, their term of office, and replacement, is hereby replaced by the following language:

"The membership of the "architectural control committee" is perpetual in nature and is established by the following procedures:

- a. A legal title holder of any lot (1-25) in said Louise Gardens Subdivision, must contact the six legal title holders who are closest to the lot who is interested in erecting, altering or placing any structure on subject lot. The six contacted legal title holders must also contact four other legal title holders to approve any construction plans, as declared and required in the "Restrictions and Protective Covenants, Louise Gardens No. 1".
- All other language and requirements concerning the "Architectural Control Committee", except as stated in item #3, provision (a), will remain in force.
- Delete all language and references to "more than on story", item #6 of Covenants, last sentence, and replace said references and language to the following:

"The ground floor area of the main structure, exclusive of one-story open porches and garages, shall be not less than 1,200 square feet.".

- 5. All other provision of the Louise Gardens No. 1 protective covenants not explicitly amended by the provisions declared in items Number 1, 2, 3 and 4 of this document, will remain in force and intact.
