QUIT CLAIM DEED

BLACK DIAMOND EQUIPMENT, LTD., a California corporation, Grantor(s) of Salt Lake City, County of Salt Lake, State of Utah, hereby QUIT CLAIM to **BLACK DIAMOND EQUIPMENT, LTD., also known as BLACK DIAMOND EQUIPMENT, LTD. INC., a Delaware corporation**, Grantee(s), whose address is 2084 East 3900 South, Salt Lake City, Utah 84124, for the sum of Ten Dollars and other good and valuable consideration, the following described tract of land in Salt Lake County, State of Utah, to-wit:

PARCEL 1:

BEGINNING at a point on the South line of 3900 South Street North $89^{\circ}55'20''$ West 100.00 feet along said South line from the Northwest corner of Lot 26, GLENWOOD ACRES SUBDIVISION, a part of the Southwest quarter of Section 34, Township 1 South, Range 1 East, Salt Lake Base and Meridian, said point also being East 1,004.707 feet and South 898.845 feet from the West quarter corner of said Section 34; and running thence South 361.57 feet to a point one foot North of the North face of Rainbow Pointe wall, said point also being 2.65 feet North of the North line of Rainbow Pointe Subdivision, recorded April 5, 1988, as Entry No. 4606294, in Book 88-4 of Plats, at Page 23, in the office of the Salt Lake County Recorder; thence South $89^{\circ}57'28''$ West 802.78 feet parallel to and one foot Northerly from said wall; to a point which is 2.06 feet North of the North line of said Rainbow Pointe Subdivision, (by Survey a point 1 foot North of the Rainbow Pointe wall is 2.17 feet North of the North line of Rainbow Pointe Subdivision); thence North $00^{\circ}06'00''$ East 363.25 feet to the South line of said 3900 South Street; thence North $89^{\circ}55'20''$ East 802.15 feet along said South line to the point of BEGINNING.

LESS AND EXCEPTING therefrom any portion lying within the current bounds of 3900 South Street.


