TO FABER LANE

ORDINANCE NO. 1318

DATE August 30, 1995

AN ORDINANCE CHANGING THE NAME OF A PUBLIC STREET IN THE PAULSEN ACRES 2 SUBDIVISION IN SALT LAKE COUNTY BEING THE STREET NOW DESIGNATED AS "1350 WEST STREET" TO "FABER LANE."

The Board of County Commissioners of the County of Salt Lake ordains as follows:

SECTION I. The names of the public street in PAULSEN ACRES 2 Subdivision in Salt Lake County currently designated as "1350 WEST STREET" is hereby changed to "FABER LANE."

SECTION II. (1) The Board of County Commissioners finds that over seventy-five percent (75%) of the owners of residential structures on the Public Right-of-Way have petitioned the County to change the name of the Public Right-of-Way and that they have complied with the provision of Section 18.28.025, Salt Lake County Code of Ordinances; that the new street name conforms to the name approved by the County Address Coordinator, the County Planning Commission and the U.S. Postal Service Officials; and further, finds that the name change will not be detrimental to the general public interest, that neither the public nor any person will be materially injured thereby, and, that in view of the foregoing, the street name should be changed accordingly.

(2) Upon payment by the petitioners of all applicable associated costs provided for in Section 18.28.025, Salt Lake County Code of Ordinances, the Salt Lake County Recorder is directed to record this ordinance and make the necessary changes on the official plats and records of the County to effectuate the purposes hereof.

SECTION III. This ordinance shall become effective fifteen (15) days after its passage and upon at least one publication in a newspaper published and having general circulation in Salt Lake County.
