AN ORDINANCE OF THE TOOELE CITY COUNCIL CHANGING THE NAME OF THE STREET SOMETIMES CALLED "THIRD NORTH" AND "500 NORTH" TO "500 NORTH" AND CHANGING THE NUMBERS OF CERTAIN BUILDINGS AND RESIDENCES ABUTTING THAT STREET

WHEREAS, there is a street in Tooele City which has been known as "Third North" and "500 North," and the apparent conflict in the names causes problems in locating addresses and jeopardizes public safety and the E-911 system; and,

WHEREAS, the street should be named 500 North according to the city's grid system; and,

WHEREAS, certain of the building and residence numbers on that street need to be changed to conform with the city's grid system and to make such places easier to locate by emergency and utility services; and,

WHEREAS, this council held a public hearing on the matter on November 3, 1993; and,

WHEREAS, the Tooele City Council has considered all comments regarding the renaming of the street and the readdressing of the buildings and finds it to be in the best interest of Tooele City and the citizens thereof to rename the street and renumber the buildings in the interest of public safety, the E-911 system and for ease in locating such street and buildings, that the renaming and renumbering will not be detrimental to the general interest, and that it should be made;

NOW, THEREFORE, BE IT ORDAINED BY THE TOOELE CITY COUNCIL that the street in Tooele City which has been known as "Third North" and "500 North" is hereby officially renamed "500 North." The numbers of certain abutting buildings and residences are hereby changed to those numbers appearing on the attached map.

This Ordinance shall become effective January 1, 1994, 1993. Ordinances in conflict herewith are hereby repealed to the extent of such conflict.

IN WITNESS WHEREOF, this Ordinance is passed by the Tooele City Council this 3<sup>RD</sup> day of November, 1993.

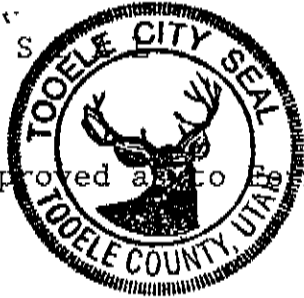

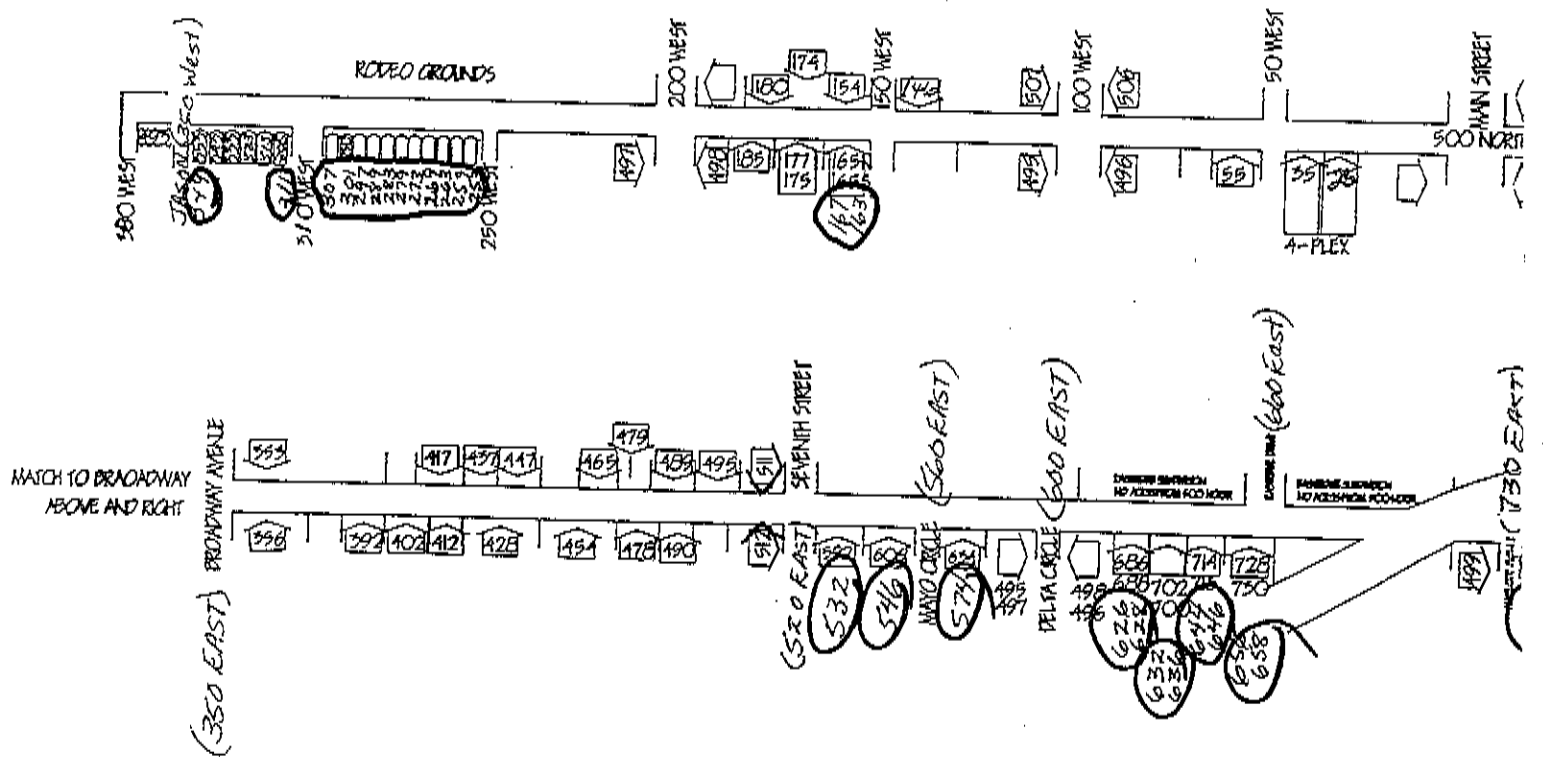
