

A RESOLUTION DECLARING THE ANNEXATION OF TERRITORY  
TO THE MUNICIPALITY OF KANAB CITY, UTAH

WHEREAS, the petition for annexation known as the "1987 KCR Annexation" was accepted by the Kanab City Council for the purpose of preparing a Policy Declaration relative to the proposed annexation on July 28, 1987; and

WHEREAS, a public hearing was held on December 8, 1987, for the purpose of discussing the Policy Declaration statement of said annexation; and

WHEREAS, the Policy Declaration statement was adopted by the Kanab City Council on December 8, 1987; and

WHEREAS, the proposed annexation, in the judgment of the municipality, meets with the standards set for annexation; and

WHEREAS, no protest was filed by an affected entity;

THEREFORE, it is hereby resolved by the City Council of the City of Kanab, Utah, that:

1. Territory Annexed - The territory described below is hereby declared annexed to the municipality:

A PARCEL OF LAND LOCATED IN SECTIONS 28, 29, 31, 32, & 33 TOWNSHIP 43 SOUTH RANGE 6 WEST, SALT LAKE BASE AND MERIDIAN; SECTIONS 4, 5, 6, 7, AND 8, TOWNSHIP 44 SOUTH, RANGE 6 WEST, SALT LAKE BASE AND MERIDIAN AND IN SECTIONS 1, AND 12, TOWNSHIP 44 SOUTH, RANGE 7 WEST, SALT LAKE BASE AND MERIDIAN AND BEING MORE PARTICULARLY DESCRIBED AS FOLLOWS:

BEGINNING AT THE SOUTHWEST CORNER OF SECTION 32, TOWNSHIP 43 SOUTH, RANGE 6 WEST, SALT LAKE BASE AND MERIDIAN, AND RUNNING TH. N 0°55'43" E 1313.21 FEET ALONG THE WEST LINE OF "KANAB CREEK RANCHOS UNIT NO. 3 SUBDIVISION"; THENCE S 88°39'43" E 1321.24 FEET ALONG THE NORTH LINE OF "KANAB CREEK RANCHOS UNIT NO. 3 SUBDIVISION" TO THE SOUTHWEST CORNER OF LOT 113, "KANAB CREEK RANCHOSE SUBDIVISION"; THENCE ALONG THE BOUNDARY OF "KANAB CREEK RANCHOS SUBDIVISION AS FOLLOWS: N 0°36'27" E 2625.26 FEET; THENCE N 89°39'16" W 2614.66 FEET; THENCE NORTH 1318.27 FEET; THENCE S 89°24'38" E 1329.41 FEET;
