

RESOLUTION NO. 12-3-87

A RESOLUTION DECLARING THE ANNEXATION OF TERRITORY
TO THE MUNICIPALITY OF KANAB CITY, UTAH

WHEREAS, the petition for annexation known as the "1987 KCR Annexation II" was accepted by the Kanab City Council for the purpose of preparing a Policy Declaration relative to the proposed annexation on July 28, 1987; and

WHEREAS, a public hearing was held on December 8, 1987, for the purpose of discussing the Policy Declaration statement of said annexation; and

WHEREAS, the Policy Declaration statement was adopted by the Kanab City Council on December 8, 1987; and

WHEREAS, the proposed annexation, in the judgment of the municipality, meets with the standards set for annexation; and

WHEREAS, no protest was filed by an affected entity;

THEREFORE, it is hereby resolved by the City Council of the City of Kanab, Utah, that:

1. Territory Annexed - The territory described below is hereby declared annexed to the municipality:
